INTRODUCTION

This proxy statement is being furnished to you in connection with the solicitation by the Board of Directors of Conneaut Savings Bank of proxies to be voted at the special meeting of members of Conneaut Savings Bank to be held on December 17, 2008 at the Bank's main office, 305 Main Street, Conneaut, Ohio at 1:30pm, local time, and at any adjournments thereof.

The special meeting is being held for the purpose of considering and voting upon a Plan of Reorganization from a Mutual Savings Bank to a Mutual Holding Company (the "Plan of Reorganization") under which, in a series of steps, Conneaut Savings Bank will reorganize from a mutual savings bank into a stock savings bank and become wholly owned by a subsidiary holding company, which will be wholly owned by a mutual holding company. Conneaut Savings Bank's reorganization into the mutual holding company structure and the formation of a subsidiary holding company and stock savings bank are referred to herein as the "Reorganization." No stock is being issued to depositors or other members of the public in connection with the Reorganization.
