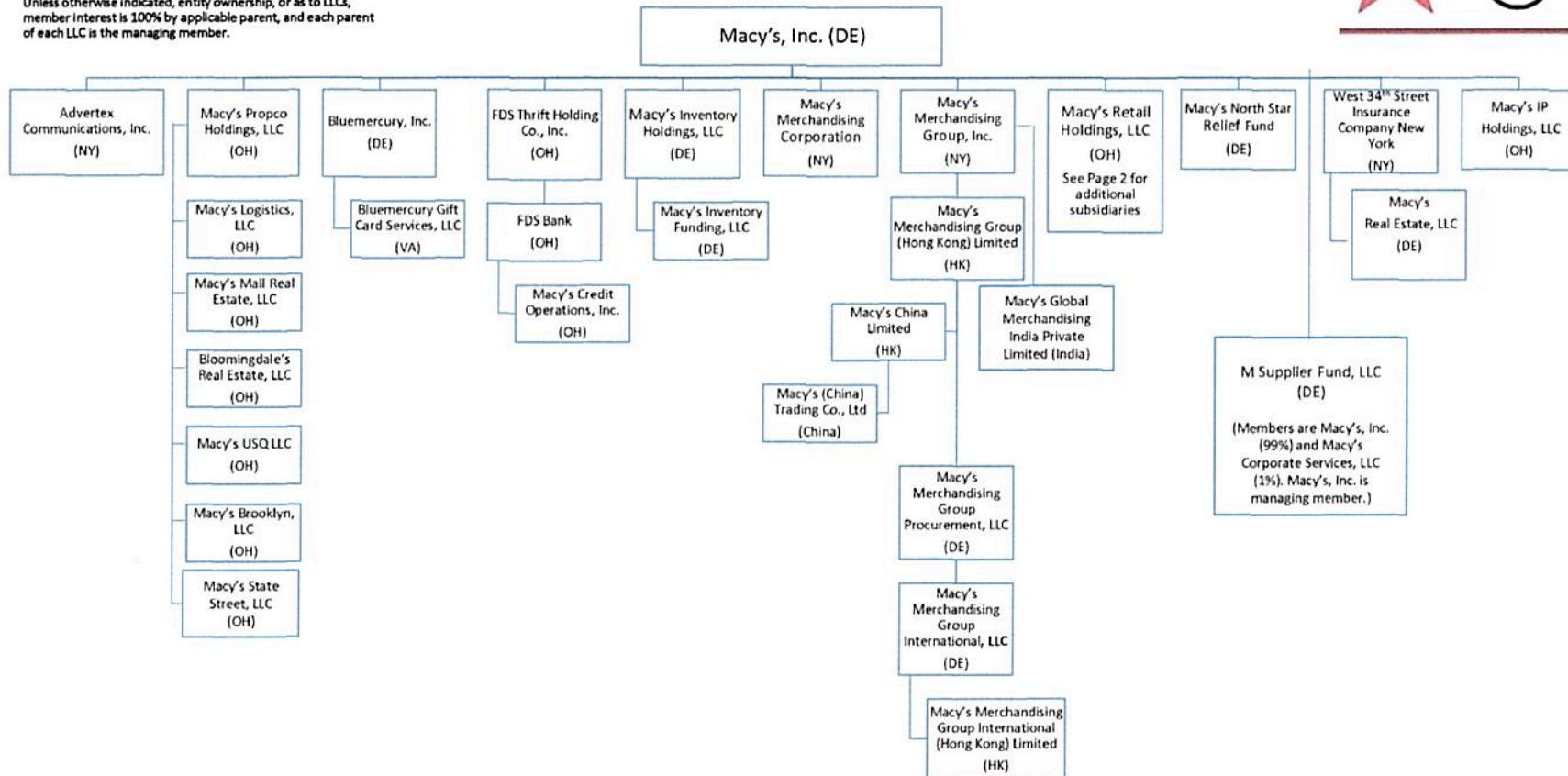

As of 2/3/24**

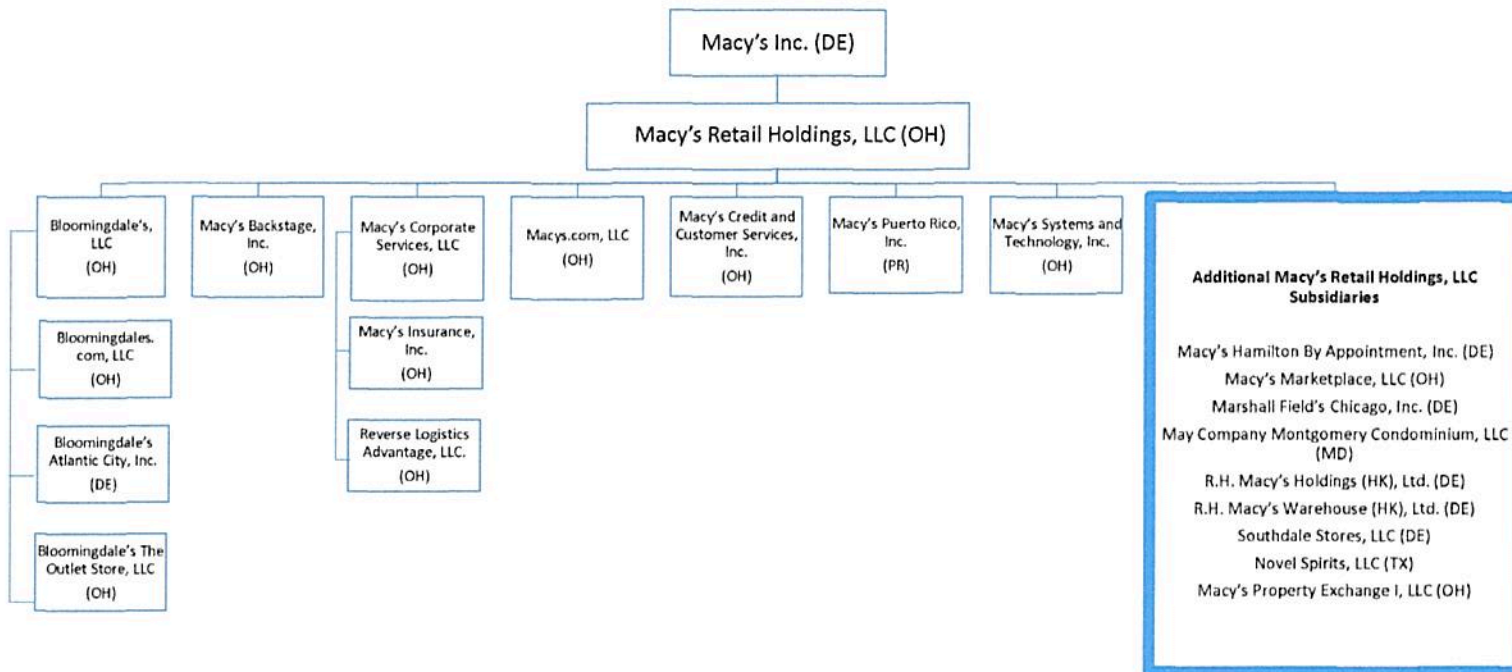
