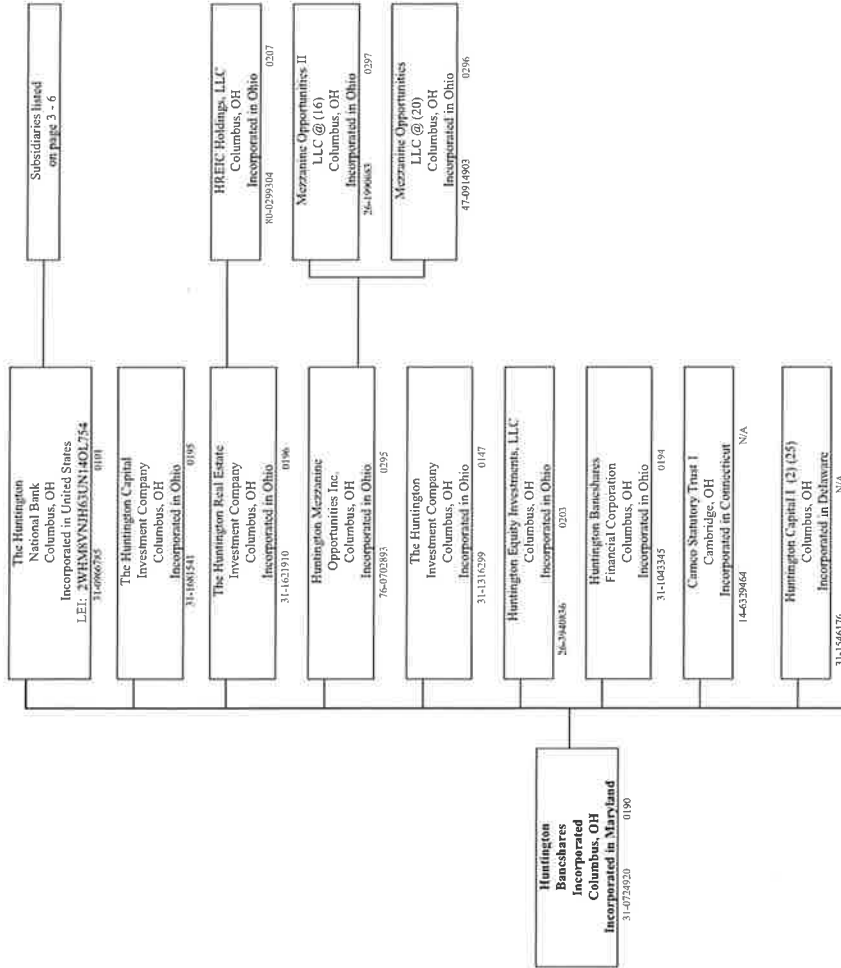

Organization Chart of Huntington Bancshares Incorporated

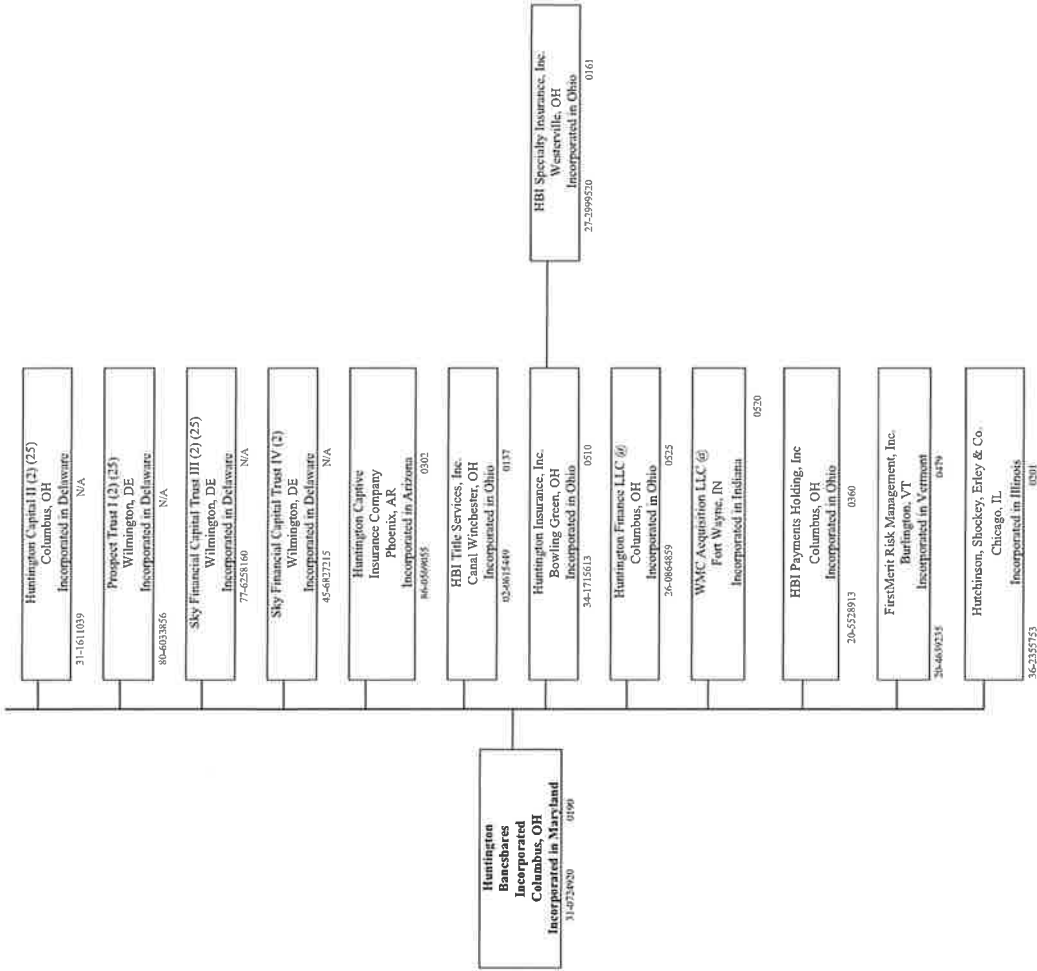

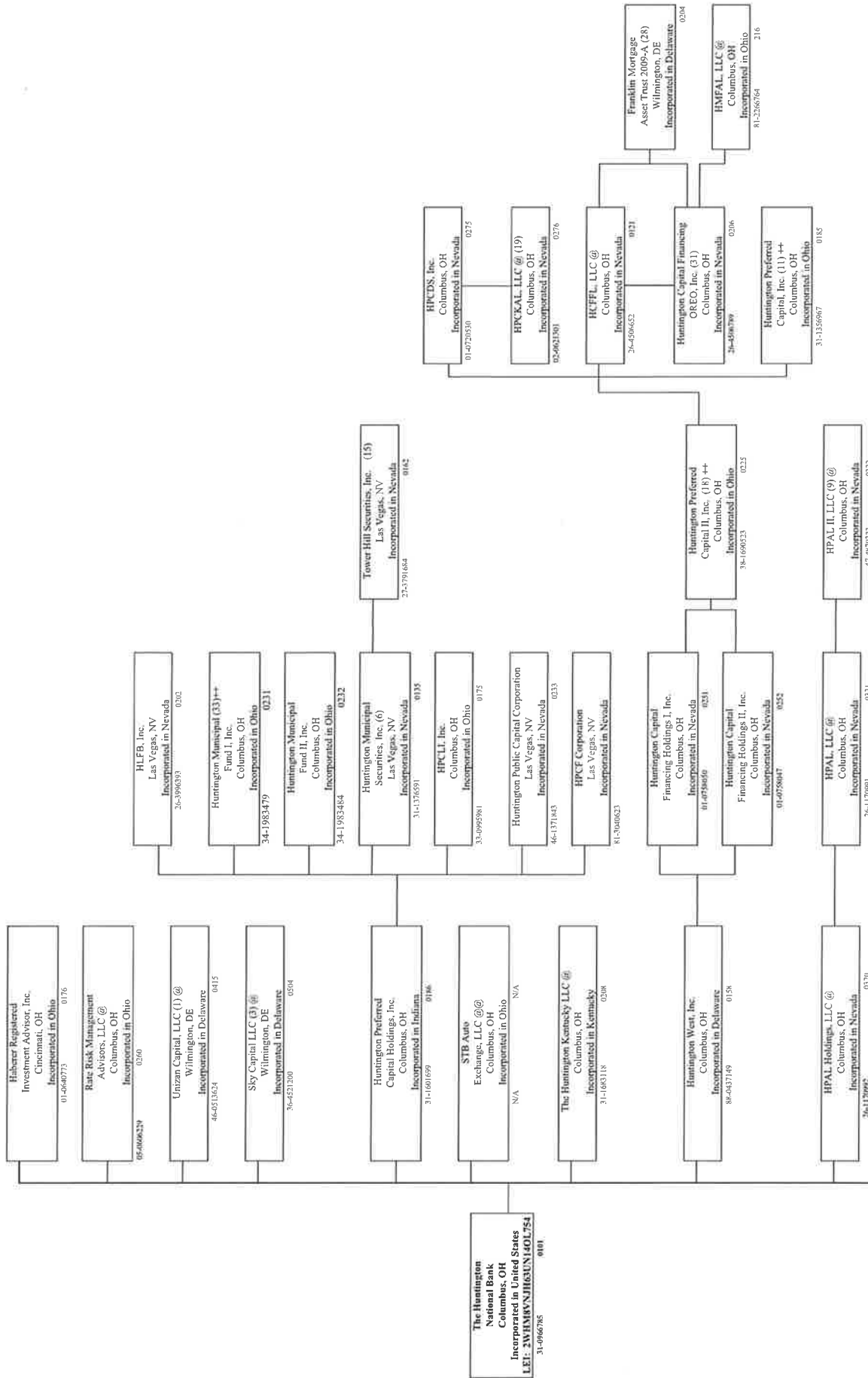

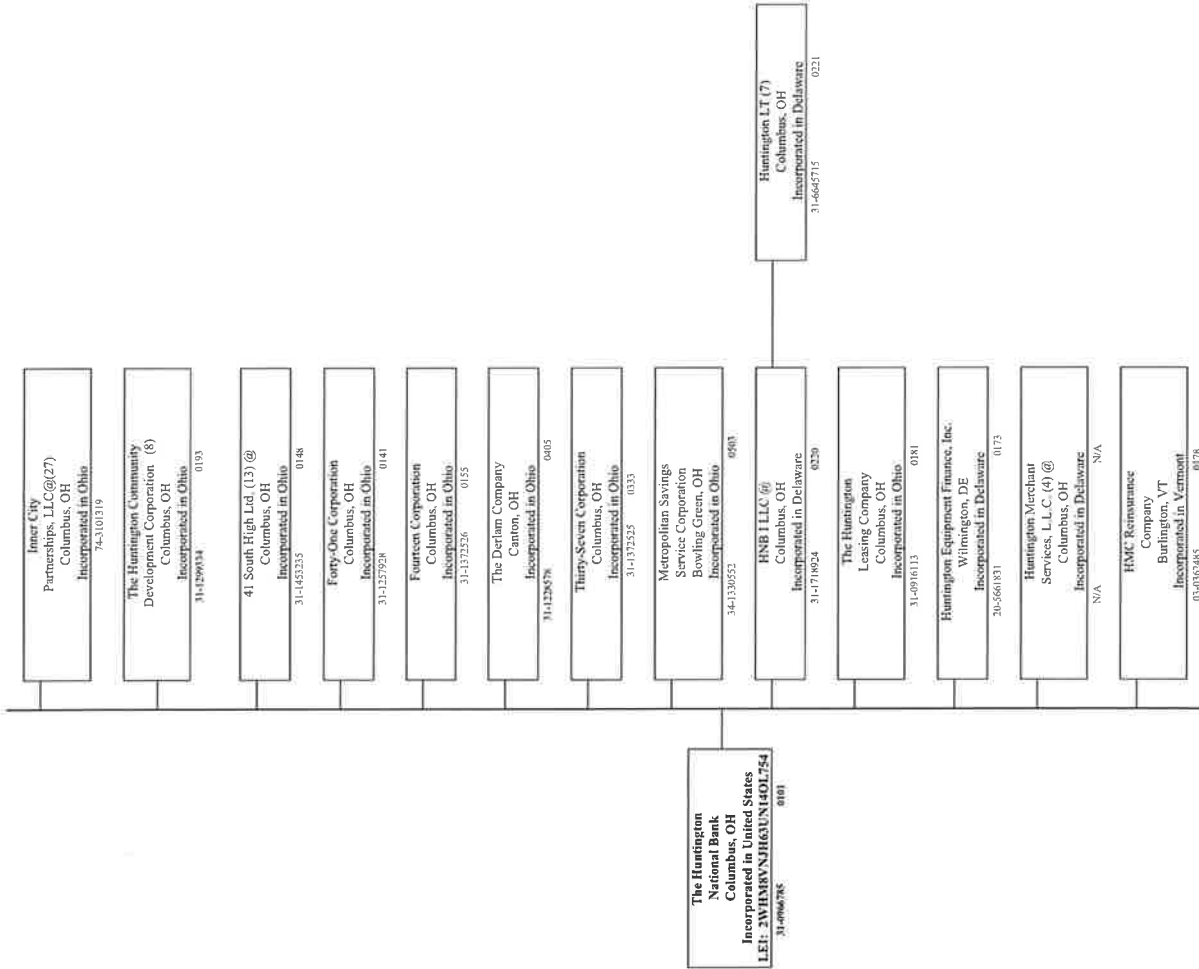

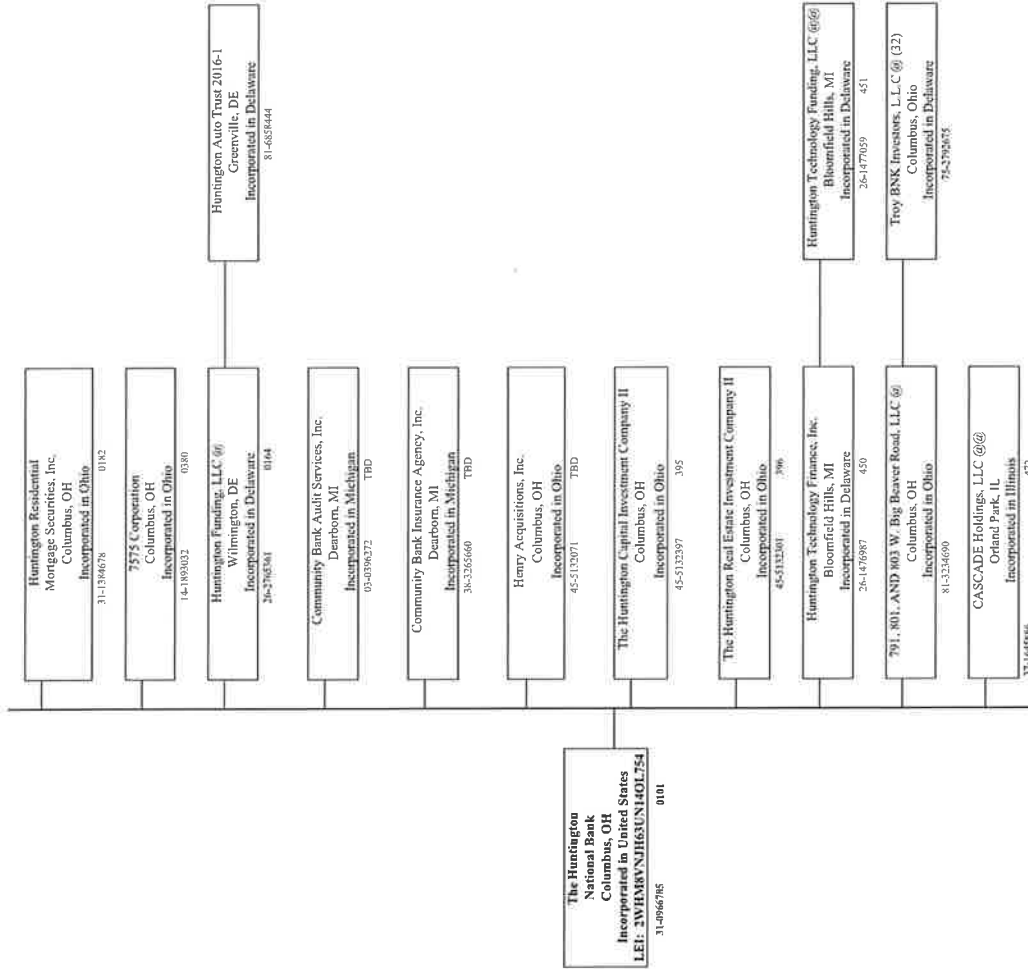

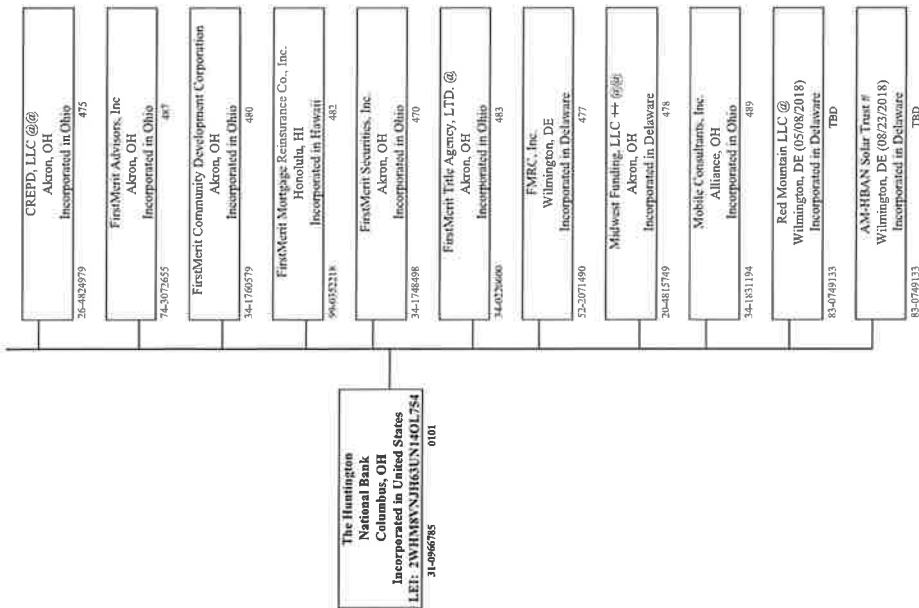
