Suppressed Data and Imputation Appendix

This appendix accompanies the reports "Rust and Recovery: A Cincinnati Retrospective" and "Rust and Recovery: A Cleveland Retrospective." Suppressed data were imputed for some of the charts in the reports, and this appendix documents the suppressed observations in each MSA and outlines the imputation method. It also provides an assessment of the imputations. The Bureau of Economic Analysis will suppress data for metropolitan areas when doing so is necessary to avoid identification of individual establishments.

Suppressed data were imputed for three figures in the Cincinnati MSA report and one figure in the Cleveland MSA report.

- Cincinnati MSA figures with imputed data:
 - Figure 2: Cincinnati MSA Sector Shares of Employment (26 imputed observations)
 - Figure 4: Manufacturing Share of Total Employment (1 imputed observation, manufacturing employment in 2015)
 - Figure 5: Manufacturing Share of Earnings (1 imputed observation, manufacturing earnings in 2015)
- Cleveland MSA figure with imputed data:
 - Figure 3: Cleveland MSA Sector Shares of Employment (9 imputed observations)

Employment Composition Charts

Sector-level data are classified according to the Standard Industrial Codes (SIC) for 1969–2000 and by the North American Industry Classification System (NAICS) for 2001–2016. We used the following SIC–NAICS crosswalk to generate the sectors identified in the following table:

- The employment composition charts in the Cincinnati and Cleveland reports, figures 2 and 3, respectively, have suppressed data.
- Suppressed data were imputed at the individual line-code level for both SIC and NAICS before being aggregated to create the sector values.

Imputation Methodology and Assessment

If three or more observations are present for a given SIC or NAICS line code, any suppressed values are imputed using the Kalman smoother available from the "imputeTS" R package.

If fewer than three observations are present for a given SIC or NAICS line code, any suppressed values are imputed using the mean of all observed data.


The imputation methodology is assessed as follows:

- Full sample size is 544 observations (256 SIC observations and 288 NAICS observations)
- Randomly insert, with replacement, 5 percent, 10 percent, and 15 percent missing values into the 544 observations
- Impute the missing values using (a) the approach described above and (b) simple linear interpolation
- Compute the percentage error between the actual value and the imputed value
- Repeat the process 5,000 times and plot the density function of errors for a given percentage of missing observations
- The median imputation error is always less than or equal to 0.4 percent






Density plots are based on 5,000 replications with 5% missing values randomly inserted. Median values of each density plot are illustrated as dashed vertical lines.

Density plots are based on 5,000 replications with 10% missing values randomly inserted. Median values of each density plot are illustrated as dashed vertical lines.




Density plots are based on 5,000 replications with 15% missing values randomly inserted. Median values of each density plot are illustrated as dashed vertical lines.






Density plots are based on 5,000 replications with 5% missing values randomly inserted. Median values of each density plot are illustrated as dashed vertical lines.
